(2a) The name, contact details and website of the charity or collection agent

(2b) The purpose for which the funds are being collected

- funding critical cancer research
- reducing cancer risk through prevention and early detection programs, and
- supporting people affected by cancer.

(2c) Details of restrictions on collection hours

- Monday through Friday 7:00am – 6:00pm
- Saturday 9:00am – 5:00pm
- Sunday 11:00am – 5:00pm
- Public holidays (other than Good Friday, Easter Sunday and Christmas Day) 11:00am – 5:00pm

(2d) Requirement to provide a receipt on request for monetary donations of \$2 or more

A receipt will be issued at the end of the financial year for ongoing collection agreements to Cancer Council SA of \$2 or more. Cancer Council SA can issue a receipt on request at any time.

(2e) Details in relation to ongoing collection agreements including the requirement for written confirmation, and how donors can cease an ongoing collection agreement

All donors will receive confirmation of their ongoing collection agreement that outlines the following:

1. The amount of the ongoing donation
2. The annual cost to the donor
3. The frequency of the agreed ongoing donation
4. The date of the commencement of the agreement
5. A statement that the donors has a right to terminate an ongoing collection agreement at any time; and
6. Details about how the donor can terminate the ongoing collection agreement

A donor can cancel their ongoing collection agreement at any time by phoning Cancer Council SA on 1300 65 65 85.

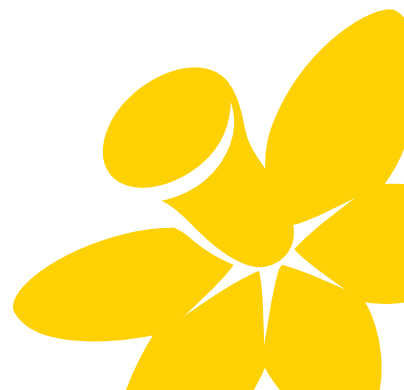
