Research

In South Australia, gifts like yours made it possible for us to fund over 50 new research grants in 2021 through Cancer Council's Beat Cancer Project. Your support for this project—which is a collaboration between Cancer Council SA, the State Government, SAHMRI and the state universities—means that researchers can perform over \$4 of research from every \$1 donated.

Margaret watched breast cancer impact three generations—her great grandmother, her grandmother and her mum. So when her best friend was diagnosed, she turned to Cancer Council 13 11 20.

"Janice was like my sister. The first time I was alone after she told me the news, I cried for what felt like hours.

We went through it together. I sat with her through every chemo session, and I shaved my head so she didn't have to do it alone. But there were some questions I couldn't answer, so I put her in touch with Cancer Council SA.

That's the thing about cancer: it's horrific for those going through it and can be really devastating to the people who are supporting them.

I called **13 11 20** myself and I found it so helpful to chat through my own concerns with the nurse. It eased my mind and helped me to better support Janice, too.

She is now in remission. I couldn't be more grateful to have my beautiful friend by my side. Since then, my ex-husband has stayed at Cancer Council Lodge while in Adelaide for prostate cancer treatment. It blew my mind to see how supportive they were and it cemented my appreciation of the role Cancer Council plays for so many people.

Hopefully they'll have to wait a little while, but my little contribution (whenever it happens) will be a gift to help Cancer Council SA continue their important work."

New research predicts that cervical cancer will be considered a rare cancer by 2022, and eliminated as a public health issue by 2035.

These figures mean that Australia is set to become the first country in the world to eliminate cervical cancer. That's the kind of advance that occurs when people like you choose to support research into cancer, and the care and treatment of people diagnosed.

Commonly asked questions



Your questions answered.

Do I have to be wealthy?

Anyone can leave a gift in their Will.

No matter the size, every gift helps with research, preventing cancer and supporting people impacted by cancer and their families.

What types of gifts can I leave in my Will?

There are several different ways to leave a gift in your Will.

A residual gift

A residual bequest is a simple way to leave a gift that won't interfere with any other specific bequests left to loved ones.

By leaving a residual gift to Cancer Council SA, you are instructing your executor that, once your debts are paid and specific gifts are distributed to loved ones named in your Will, the remainder (or a proportion of the remainder) of your estate will be gifted to Cancer Council SA.

A fixed specific gift

A gift in the form of other property such as real estate, shares, vehicles or items of jewellery.

Whole or part of your estate

You can leave your entire estate or any part of your estate to Cancer Council SA.

A fixed sum of money

Also known as a pecuniary bequest, this gift takes the form of a specific cash amount.

Your solicitor can advise you of ways to ensure the gift retains its relative value (for example, by increasing the amount by reference to CPI).

Why would I allocate my gift to 'general purposes' rather than something specific like research?

It's entirely up to you whether you want to specify how your gift is used, or whether you will trust that Cancer Council SA will put it to the best possible use at the time.

Most of our supporters choose to include a gift for 'general purposes'.

The work of Cancer Council SA is vast and varied. What's more, it changes over time as community needs shift and new research breakthroughs occur.

Therefore, the more flexibility we have to direct your gifts in the best way possible, the better equipped we are to make the future cancer free.

Some people do choose to direct their gift to a particular type of cancer or other area of personal interest, perhaps because of their own experience with cancer or in tribute to a loved one lost to cancer. These gifts are welcomed, and we would be delighted to honour your wishes.

Do I need a solicitor?

If you're thinking of making or changing your Will, you're making an important decision about your values and priorities.

We strongly suggest you talk to an expert.

A solicitor can help you draft a Will.


Some people draft their own Wills using kits online or bought from a newsagency or post office.

However, there are certain requirements for a Will to be valid and using a solicitor will make sure you get it right.

Is there a simple way to change an existing Will?

If you already have a Will, then the most cost-effective way to include a gift to Cancer Council SA is by adding a codicil—a short legal amendment—to your Will.

Check with your solicitor if a codicil is appropriate for the updates you wish to make. Adding a codicil could be done via a simple email exchange with your solicitor and then visiting their office to sign the amendment.



Legal requirements



Easy steps to leave a gift in your Will.

Including a gift in your Will to Cancer Council SA is simple to do, and goes a long way in making a cancer free future possible for generations to come.

Step 1: Speak to your family and loved ones

Leaving a gift in your Will is a personal decision but it can be helpful to tell your loved ones about what you've planned.

Step 2: Decide what kind of gift to leave

There are three main ways to leave a gift in your Will to Cancer Council SA:

Residual

You can leave a portion of your estate, or the balance remaining after loved ones and expenses are provided for.

Specific

You can leave a specific sum of money.

Accet

You can leave specific items of value such as shares or real estate.

Step 3: Get the help of a professional solicitor

Whatever your circumstances, we recommend that you see a solicitor when writing or updating your Will to ensure your wishes will be fulfilled.

Step 4: What's the correct legal wording?

The correct legal wording to include a gift to Cancer Council SA in your Will is below. Select the wording that best reflects the kind of gift you wish to leave.

- Cancer Council SA welcomes donations to specific areas or cancer types, and we will honour individual wishes. However, the needs of research and support services are vast and varied, and we need to respond to changes in knowledge, practice or treatments.
- 3. While we are committed to honouring the wishes of your client first and foremost, the more flexibility there is to invest a gift, the better. If you need to discuss a specific request, please contact us.

- 4. If your client would like to establish a legacy in recognition or memory of a loved one, we would encourage you to contact us to discuss the opportunity of titled research awards or scholarships.
- 5. Cancer Council SA believes that family comes first. We would encourage you to recommend that your client consider a gift to Cancer Council SA after taking care of loved ones.
- 6. Please encourage your client to contact us so we can acknowledge their bequest by inviting them to join the Cancer Council SA Bequest Society.
