Preventive Health SA and Cancer Council SA will work collaboratively to reduce skin cancer incidence and mortality in South Australia, ensuring the available investment is aligned to the Framework's objectives, priority populations and settings.

Evidence based, coordinated and sustained action will underpin implementation of the Framework. Preventive Health SA and Cancer Council SA will promote interagency action and facilitate links with other Government and non-government agencies.
